You may qualify for a free monthly box of food through the Food Bank’s Senior Box Program.

To be eligible, you must:

- Be 60 years of age or older
- Meet the income guidelines
- Provide a valid ID

What’s in the box?

- 7-8 cans of vegetables
- 2-3 cans of fruit
- 1-2 bottles of juice
- 2-3 cans of beef, poultry and/or fish
- 3 jars/cans of peanut butter and/or beans
- 2 packages of cereal, grits and/or oats
- 2 pounds of pasta and/or rice
- 2 packages of shelf-stable milk
- 2 pound block of cheese
